## FY09/10 Implementation Highlights:

- ✓ Most of FY09/10 was spent assembling the PEI team, identifying and improving office site in Ceres, developing RFP for community-based PEI project implementation, reviewing and selecting implementers and negotiating contracts.
- ✓ Two programs began in FY09/10 and served 1731 individuals; Expanded Child Sexual Abuse Prevention & Early Intervention Program and In Our Own Voice.
- The Behavioral Health Summit in May 2010 kicked off our adoption of the Results Based Accountability (RBA) Framework. Mark Friedman, the originator of RBA, did a key note address during the summit and a full day of RBA 101 training for key BHRS staff and community-based organizations. A train-the-trainer session with Mark was scheduled to occur in FY10/11.
- ✓ Numerous steps related to the PEI implementation process, both seen and unseen, are moving us toward a "help first" system and community for individuals of all ages and all types of behavioral needs.
