

- Innovation (INN)


Garden Gate Respite - Bed Expansion CSS Program Background

- Outreach and Engagement emergency housing program operated by Turning Point Community Programs
- Funded in 2006 for homeless individuals and/or at risk of homelessness
- > 6 beds with 24/7 on site program staff
- Critical option in continuum of care used by agencies including law enforcement, emergency services, outreach teams
- Positive outcomes 48% of individuals were referred to respite to avoid acute psychiatric hospitalization *


Garden Gate Respite/Innovation Project



- Utilized 5 beds
- Located in house next door to GGR CSS program
- Final project report with evaluation outcomes due on or before June 30, 2016


Garden Gate Respite Bed Expansion - CSS

- Annual Update Public Hearing at Mental Health Board/ABSAP joint meeting on April 28, 2016
- BHRS staff advocated that 5 beds from GGR INN project be moved to GGR CSS program
- Provide total of 11 beds
- Ongoing demand for emergency housing
- Expansion cost \$526,694 yearly



Garden Gate Respite Bed Expansion - CSS Stakeholder Approval

- BHRS e-mails to stakeholders May 4, May 6, 2016 requesting expansion approval
- > 27 of 37 MHSA stakeholders voted
- > 26 votes in favor, 1 opposed
- Expansion included in Annual Update to Board of Supervisors on June 28, 2016



Suicide Prevention Innovation Project

- Approved by MHSOAC on April 28, 2016
- Adapts a collective impact model to integrate community sectors to more effectively address suicide problem
- Increase quality of mental health services including measurable outcomes
- Work underway to secure staff and develop Scope of Work
- Ideas on how to set up sectors?



History of Contributions to CalMHSA



- February 27, 2015
 Stakeholders endorse funding CalMHSA Prevention and Early Intervention (PEI) Statewide Initiative \$90,000
- June 2, 2015
 Board of Supervisors approves funding proposal included in MHSA Annual Update
- July 17, 2015 Stakeholders approve proposal to increase allocation by \$30,000 included in MHSA Plan Update

History of Contributions to CalMHSA



September 1, 2015

MHSA Plan Update presented to Board of Supervisors

No action taken at meeting

Concerns that local suicide prevention efforts could be more effective

PEI funds not expended

- Central Valley Suicide Prevention Hotline serves Stanislaus, Merced, Fresno, Tulare, Kings, Madera, and Mariposa counties
- Hotline: 1-888-506-5991
- Funded by California Central Valley Counties operated by Kings View Behavioral Health Systems
- Hotline provides quarterly call volume reports/demographics important for recently approved Suicide Prevention Innovation Project work

Central Valley Suicide Prevention Hotline



- Call volume for Stanislaus County has increased
- Stanislaus County is second largest call user behind Fresno County

Central Valley Suicide Prevention Hotline



- Approve estimated funding amount of \$48,371 a year for Central Valley Suicide Prevention Hotline via CalMHSA
- Apply remaining funding for future PEI projects
