MHSA Updates

On June 14, 2022, the Board of Supervisors (BOS) approved the Mental Health Services Act (MHSA) Annual Update for Fiscal Year 2022-2023, which included the Program and Expenditure Plan (PEP) for Fiscal Year 2022-2023 and reported actual results from Fiscal Year 2020-2021 (Resolution No. 2022-0282). The Program and Expenditure Plan for Fiscal Year 2022-2023 became effective on July 1, 2022.

MHSA proposes to expand the following funding categories in FY 2022-2023 Community Services & Support-General System Development

Central Valley Homes Development Project

The Central Valley Homes Development Project is a collaborative effort involving Stanislaus County Behavioral Health and Recovery Services (BHRS), the Stanislaus Regional Housing Authority, F&M Bank, and the City of Modesto. The partners are working together with their respective missions to increase safe, affordable housing for persons with Serious Mental Illness (SMI) who are homeless or at risk of homelessness. Central Valley Homes is a 2-development scattered site located at:

1143 Park Street, Turlock

413 Vine Street, Modesto

Central Valley Development Funding Partners

- Total Project Cost estimated to be around \$11.74M
- BHRS proposes to contribute approximately \$2.43M of General Services Development funds to support the Central Valley Development Project

Central Valley Homes Development Project (Cont.)

- 46 permanent supportive housing units
- 3 rehabilitation units
- 43 new construction units (36 onebedroom units and 1 two-bedroom)
- BHRS funding will allow for 18 units to be reserved for BHRS clients meeting criteria.

LEGACY ALLIANCE OUTREACH (LAO) Increase current funding from \$390K to \$405K to support program start-up and development


Original summer program evolving to afterschool program in the upcoming school year

Goal is to engage transition-aged youth in positive mentoring and coaching.

Program model includes the use of EBP Curriculum. Mental Health Education & Prevention strategies. Has a specific focus on gang prevention.
